Contents show] History Edit AutoCAD is one of many applications that were conceived by its creators as part of a larger software package called Enterprise Project Management (EPM), which was designed as a groupware system. This type of software package allowed users to collaborate on complex projects, working from the same desktop, using a common language to transmit information, draw schematics, and change project parameters in real time. As computing became affordable and accessible to the public in the 1980s, computer-aided design software applications began to show up on personal computers. In 1984, Autodesk developed AutoCAD for Windows, which they initially planned to market to a small group of users in the transportation and chemical industries. The software would make it easier for their customers to draw their own designs. During development, Autodesk realized that the free version of AutoCAD, DOS AutoCAD, would be a potential revenue source for their new product. The first generation of AutoCAD was a great success. The software sold steadily and the demand for more and more functions grew. In the following years, AutoCAD was released as an OEM (original equipment manufacturer) product for the first time, and as a "homebrew" version. These versions were not sold by Autodesk, but by third parties. But as the software grew and the home user market grew with it, Autodesk decided to release the first version of AutoCAD as a standalone product, and with the same license terms as the OEM version. The first standalone version was released for the

Macintosh operating system in 1985. DOS AutoCAD was first released in 1986 and Win-32 AutoCAD was first released in 1988. This version of AutoCAD was officially marketed as "AutoCAD 97", and offered 64 levels of drawing and advanced functions, and was more like the standard AutoCAD version than the OEM. The simulations show that the transition is of first order, and that the domain sizes at the phase transition are larger than the ones estimated by the mean-field

approach. This size increase is caused by fluctuations in the structures. The transition temperature is in good agreement with previous experimental studies.
