PER CURIAM: In this attorney disciplinary matter, respondent and the Office of Disciplinary Counsel ("ODC") have entered into an Agreement for Discipline by Consent pursuant to Rule 21, RLDE, Rule 413, SCACR. In the agreement, respondent admits misconduct and consents to a definite suspension of three years and one day, retroactive to the date of her interim suspension, see In re Hughes, 339 S.C. 99, 530 S.E.2d 133 (1999). We accept the agreement and issue a judgment of guilt against respondent finding she violated Rules 4.1 and 8.4, RPC, by her misconduct. We also order that respondent be suspended from the practice of law in this state for three years and one day from the date of her interim suspension. Further, we assess respondent \$4,000 in costs to be paid to the Commission on Lawyer Conduct ("the Commission").[1] Respondent was admitted to the South Carolina bar in 1993. Her misconduct occurred while she was practicing under a trustee in bankruptcy. Law Rule 4.1, RPC, states: "In representing a client, a lawyer shall not... (b) communicate about *641 the subject of the representation with a person the lawyer knows

to be represented by another lawyer in the matter, unless the lawyer has the consent of the other lawyer or is authorized to do so by law or a court order."
