Boulos appeals the district court order denying her motion for contempt of court and her motion to modify or correct a visitation schedule. Mary contends that the order does not comply with the terms of the parties' stipulated visitation agreement. We agree, and remand the case with directions. Mary and James have three children. Mary filed an application for modification of a visitation order dated August 31, 1992. The court modified the visitation order in a December 28, 1992, order to include a one-week visitation schedule for James during Christmas season. James subsequently filed a motion to enlarge the visitation schedule to include Thanksgiving Day and two consecutive weekend visits. He testified that he and Mary had been "sincere in our efforts to reconcile our differences and to put our divorce behind us." The court granted the request on July 26, 1996,
